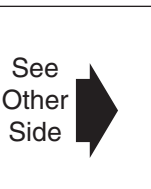

TERMS & CONDITIONS

I hereby agree to abide by all rules and regulations, present, and future, of the Nebraska State Racing Commission, Fonner Park (Hall County Livestock Improvement Association) and agree as final the decision of the Stewards and the Commission on all racing matters.

By the acceptance of this application, the owner and/or trainer agrees to indemnify and hold harmless the Hall County Livestock Improvement Association (hereinafter known as Fonner Park), its officers, agents and employees against any and all claims, damages, liabilities, losses, costs or expenses, including reasonable attorney's fees as a result of or arising out of directly or indirectly, any action or conduct by the applicant, trainer, owner, their agents, employees and/or animals.

The undersigned (acting on behalf of himself, or his principal, or their agents or employees) agrees, in consideration of and as a condition for the acceptance of this application, to make no claim against Fonner Park, the Hall County Livestock Improvement Association or anyone acting by or through them, for loss, damage or injury to any property, animal or person resulting from any cause (other than active negligence or willful act of an agent or employee of Fonner Park) including the negligence of any third party connected with any of the activities at Fonner Park.

The applicant agrees that if the license granted to the applicant, owner or trainer (acting as agent for the owners) is revoked, the applicant, owner, or trainer shall upon notice from Fonner Park leave the premises and remove his/her horses from the stalls along with all equipment and other personal property.

I have read the terms and conditions upon which this application for stalls will be considered, and I thereto and will abide by same.

A current Health Certificate (issued within 30 days of arrival) is required prior to entry to Fonner Park. All Horses Entering the Grounds must have been vaccinated with an FDA approved virus vaccine for EHV-1 not less than 14 days and not more than 120 days prior to date of entry. It is highly recommended horsemen keep every horse admitted to Fonner Park on a 90 day booster schedule.

Stall Application Deadline - January 2nd, 2023

**Horses that have been approved on stall application will be allowed on grounds December 1st, 2022
Main Track Opens December 15th, 2022**

PLEASE DO YOUR PART AND CLEAN YOUR HORSE STALLS

There will be a \$15.00 stall cleaning fee charged for each horse approved on the 2023 stall application if stalls are not cleaned upon departure. The stall man must be contacted to approve the stalls before departure.

FONNER PARK SCREENING RULES 2023

- No maidens over 8 years old allowed.
- All horses over 12 years old are ineligible unless approved by the Racing Commission.
- MEETING ELIGIBILITY REQUIREMENTS DOES NOT IMPLY AUTOMATIC STALL APPROVAL!
- It is the responsibility of the trainer to only bring horses which meet the 2023 Fonner Park Screening Rule.
- Requirement of a negative Coggins (equine infectious anemia) test on horses over six months of age imported into Nebraska.

All racing participants, or "Covered Persons," are required to **register themselves, and any horses in their care.** You are considered a Covered Person if you are **licensed by a State Racing Commission (SRC) AND:** You have involvement with thoroughbred Covered Horses or thoroughbred Covered Horseraces; **OR** You have access to restricted areas of a racetrack in the ordinary course of your work.
